## Jurisdiction: Federal

The federal courts in Canada, which include the Supreme Court of Canada, are constituted pursuant to section 101 of the *Constitution Act, 1867*. These courts are statutory courts; they do not exercise an inherent jurisdiction. Resort to these courts should be rare and should always conform to a strict interpretation of the *Federal Courts Act*. When in doubt, conduct additional research.

*Unlike clerks in service to the provincial superior courts, registry officials at the Federal Court of Appeal and Federal Court may be expected to be competent, diligent, and helpful.*

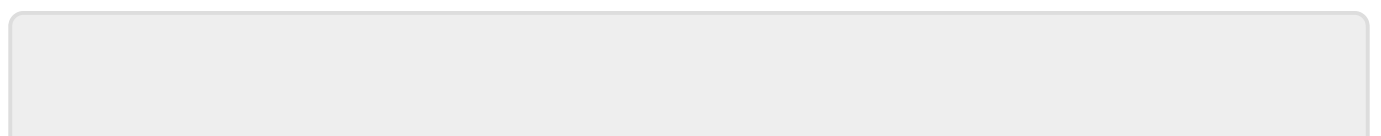
